Mayor Wunderlich brought the meeting to order at 7:00pm.

1. Mayor Wunderlich led the Pledge of Allegiance.

ORDINANCE #190

Title 11- Zoning Regulations  
Chapter 1- The Zoning Act  
Section 2- Definitions

11-1-2: Adding fence to the definitions:

Fence: A masonry wall or a barrier composed of posts connected by boards, rails, panels, or wire for the purpose of enclosing space or separating parcels of land. The term “fence” does not include retaining walls.

Title 11- Zoning Regulations  
Chapter 2- General Zoning Provisions  
Section 15- Fences

## 11-2-15: Adding fences to the General Zoning Provisions:

Fences must be erected on or within property lines.

- A. Shall be installed with the finished side facing the adjacent property or public right-of-way, and the fence posts must be located on the inside of the fence facing the property on which the fence is located.
- B. Material permitted for residential and commercial zones. All fences in residential and commercial zoning districts shall be constructed from materials which are commonly used for fencing. No fence shall be constructed from railroad ties, wood pallets, tires, rubble, metal panels, or salvaged material. Commonly used fence materials include wood, brick, stone, split railing, chain link wire, vinyl, ornamental iron work. Any materials not listed are subject to special review.

### 8-1-3: Streets and Avenues

Streets and Avenues in Valier are 80ft wide with the exception of Teton Avenue between 10<sup>th</sup> Street and 4<sup>th</sup> Street and Montana Street from the town limit to Teton Avenue, they are 96ft wide in accordance with the Valier townsite map dated 1937.
